CHIPPEWA FALLS ROTARY FOUNDATION TRUCK RAFFLE

OFFICIAL RULES

Chippewa Falls Rotary Foundation is a nonstock non-profit corporation incorporated under the laws of the State of Wisconsin, located in Chippewa Falls, Wisconsin. The Chippewa Falls Rotary Foundation Truck Raffle ("Raffle") is conducted by the Chippewa Falls Rotary Foundation for the purpose of generating funds to support its charitable purpose, activities, and programs in the Chippewa Valley.

- 1. Eligibility.** Each entrant, by purchasing a single entry ticket (a "Ticket") and entering the Raffle, agrees to abide by these rules, as well as all applicable local, state and federal laws and regulations, and further agrees to release the Chippewa Falls Rotary Club and the Chippewa Falls Rotary Foundation, and their respective directors, officers, divisions, associates, agents, employees, and volunteers from any and all liability with respect to all aspects of the Raffle, including, but not limited to, the selection process. The Raffle is open to any eligible person residing in or visiting Wisconsin, unless prohibited by law or these Rules. Pursuant to Wisconsin law, any Entrant who is not 18 years of age or older must have the written and notarized permission of his or her parent or legal guardian in order to take title to the vehicle that is the Raffle Prize.
- 2. Ticket Purchases.** The price to purchase a Ticket for the Raffle is \$100.00 (U.S. funds only) and is not tax deductible. Any entrant may purchase more than one Ticket. Participants can enter the Raffle by purchasing one or more Tickets: (a) through Chippewa Falls Rotarians selling Tickets at events throughout Wisconsin beginning April 27, 2019 through 12:00 noon on Saturday, September 7, 2019; and (b) online at the Chippewa Falls Rotary Club Website. All Tickets being purchased online must be picked up in person from a Chippewa Falls Rotarian. No Tickets will be mailed to any Ticket purchaser, no exceptions. Ticket payment can be made by Visa, MasterCard, Discover, American Express, cash, check, or money order. If a bank, for any reason, dishonors an entrant's payment, the Ticket(s) purchased with such payment will be declared invalid unless full and satisfactory payment is made prior to the Raffle drawing. Any dishonored credit card will be considered an invalid entry and Chippewa Falls Rotary Foundation will attempt to notify the entrant by mail, email, or telephone; however, the Chippewa Falls Rotary Foundation will have no liability if it is unable to notify any such entrant after using reasonable efforts to do so. Irrespective of the time and place of Ticket purchase, completed Ticket forms must be in possession of the Chippewa Falls Rotary Foundation by 12:00 Noon on Saturday, September 7, 2019. All Ticket forms will be handled and recorded on a first come, first serve basis. Any Ticket forms and payments (including payments previously dishonored) received after closure of the Raffle will be returned to the entrant.
- 3. Prizes.** The **Raffle Grand Prize** is a 2019 Ford F-150 (model 302a-XLT) (MSRP \$49,555.00) or \$25,000.00 cash. The Grand Prize Winner must claim the prize no later than October 1, 2019, and take title to the vehicle no later than by October 31, 2019. The Winner is responsible for all costs associated with title, registration, licensing, delivery, and other applicable fees (including any taxes and fees imposed by a non-U.S. resident winner's country of residence and/or domicile) associated with the Prize, as well as for all local, state, and federal taxes, including without limitation all luxury, special, and income taxes that may be applicable. The Winner will be required to provide the Chippewa Falls Rotary Foundation with a valid social security number (or equivalent for a non-U.S. Winner) and must complete all IRS and similar forms requested by the Chippewa Falls Rotary Foundation prior to delivery of the Prize. Failure to do so within thirty (30) days of request shall result in forfeiture of the Prize and award of the Prize to another entrant. Chippewa Falls Rotary Foundation

4. **Winning Chances.** A maximum of 1,000 Tickets will be sold. Each Ticket represents one chance to win the Prize. You may enter as many times as you wish. Chances of winning the Prize depends on the number of eligible Tickets sold.
5. **Drawing.** The Winner will be determined by a random drawing of all the eligible Tickets received by the Chippewa Falls Rotary Foundation by 12:00 noon on Saturday, September 7, 2019. The drawing will be held at 12:00 noon, September 7, 2019, at Toycen Ford – Chippewa Falls, once all tickets are collected and placed into the drawing container. The entrant need not be present to win the Prize. The random drawing for the Prize will be conducted in a single drawing session. During the drawing session, Chippewa Falls Rotary Foundation will draw successive provisional winning entries to be used if a potential Prize winner for any reason does not claim the Prize for which his or her entry was selected, or is determined to be ineligible. The first selected entry will be awarded the Prize, subject to confirmation of eligibility, Prize acceptance and entrant's compliance with the Raffle Rules. In the event the Prize is not awarded to such entrant, the process will be repeated with the next selected successive entry, as necessary to award the Prize. The Chippewa Falls Rotary Foundation will retain its portion of all the Tickets for one (1) year. Ticket holders who wish to view the drawing may be present at Toycen Ford – Chippewa Falls on September 7, 2019.
6. **Winner.** The Winner will be notified in person, if present, otherwise by telephone, e-mail, or by U.S. Postal Service mail based on the information received on the Ticket registration form. The Winner's name will be available to all media and listed on Chippewa Falls Rotary Club website, no later than October 31, 2019. To receive the Winner's name by mail, send a stamped, self-addressed envelope to Chippewa Falls Rotary Foundation - Raffle, P.O. Box 725, Chippewa Falls, WI 54729. The Prize Winner agrees to allow Chippewa Falls Rotary Club and Chippewa Falls Rotary Foundation to use his or her photo, name, and likeness, and any statements made regarding the Prize for advertising or publicity purposes, without compensation or prior approval. The Winner may be required to complete and return an affidavit of eligibility and liability release. Upon failure to do so if requested or failure to comply with these rules and/or to make arrangements to claim the Prize within fourteen (14) days of notification, the Prize will be forfeited and awarded to the next Ticket drawn.
7. **Awarding of Prize.** More than one name may be listed on a registration form, but the first name listed on the winning Ticket shall be deemed to be the Winner. A social security number (or equivalent for a non-U.S. Winner) must be provided, and it must be that of the Winner. Delivery of Prize shall be made solely to the Winner. It is the sole responsibility of the Winner in a multiple party entry to allocate any such Prize among the participants in such multiple party entry. The Winner is solely responsible for all applicable taxes, licenses, registration fees imposed by any applicable governmental authority, and any transportation or shipping fees. Chippewa Falls Rotary Foundation is required to collect applicable U.S. Federal income taxes, based on the Approximate Retail Value ("ARV") of the Prize, net of ticket

cost, from the Winner of the Prize, before the Winner may take possession of the Prize. Chippewa Falls Rotary Foundation will report to the IRS any awarded Prize valued at more than \$600.

8. **Authority and Control.** The decision of the Chippewa Falls Rotary Foundation shall be final in all matters concerning the Raffle. The Raffle is subject to the laws of the State of Wisconsin. Void where prohibited by law.
9. **Vehicle.** The 2019 Ford F-150 Crew Cab is provided with support from Toycen Ford of Chippewa Falls, Wisconsin.
